Subject: Guidelines for Teaching, Learning, Assessment, and Evaluation

During the Coronavirus Disease (COVID-19) Pandemic Situation for Semester 2/2021

Prince of Songkla University, Phuket Campus recognizes the risks of the new wave of coronavirus disease 2019 (COVID-19) outbreak in Thailand and in Phuket; therefore, to prevent and curb the spreading of the infection, we would like to set the guidelines for teaching, learning, assessment, and evaluation during the coronavirus disease (COVID-19) pandemic situation for Semester 2/2021, as follows:

1. Teaching and learning management

Phuket Campus offers onsite classes for all student classifications with the following conditions:

1.1 Students who have received vaccination against COVID-19 as specified below are allowed to study in class:

- 2 doses of AstraZeneca, Pfizer, Moderna, Sinopharm, and Sputnik V, or at least 1 dose of Johnson & Johnson.
- 1st dose of Sinovac and 2nd dose of AstraZeneca.
- 2 doses of Sinovac with a third booster vaccination within a week of resuming regular classes.

1.2 Students must show a COVID-19 vaccination certificate from the “Mor Prom” Application or an international COVID-19 vaccination certificate to the lecturer before entering the classroom.

1.3 Lecturers must be fully vaccinated against COVID-19 according to the vaccination guidelines.

1.4 Lecturers must provide in-class teaching. In the case that students are unable to comply with the conditions mentioned above, they must submit a request for permission not to attend onsite class indicating the reasons to the faculty for approval. Failure to do so will be considered absent from class. Students can download the request form from the QR code below and submit it through the contact channels of

each faculty. In this regard, lecturers have to manage teaching regular classes (onsite) along with online teaching simultaneously or other integrated teaching-learning methods that can assess and evaluate the learning outcomes according to the objectives set forth in the subject.

1.5 Phuket Campus conducts COVID-19 testing using Antigen Test Kit (ATK) for lecturers and students twice a month.

2. Learning assessment and evaluation formats must be adjusted accordingly to suit the situation, with the approval of the faculty and college. Lecturers must inform all students the assessment and evaluation formats of the subject.
3. Services provided on campus and in each faculty and college such as classrooms, library, laboratories, and reading areas can be opened by strictly adhering to the D-M-H-T-T principle of the campus, faculty, college, and Phuket province.
4. Some adjustments to the guidelines may be made to comply with the Order of Phuket's Coronavirus Disease 2019 Prevention and Control Measures.
5. For cases other than those specified in this announcement, a request must be submitted to the Vice President of PSU Phuket Campus for consideration, on a case-by-case basis.

This announcement shall be effective from January 4, 2022 until further notice.
